

# CONTESTANT INFORMATION

**The Mr. Detroit Eagle contest will take place on Friday and Saturday, Nov. 20 and 21. Friday night is scheduled to be a "Meet and Greet" night where the contestants, judges, and patrons can all meet in a casual atmosphere. We'd like everyone to be there by 10:30 and plan to stay til at least 1 am. Saturday is the day of the contest. We're asking all contestants and judges to be at the bar no later than 8:30 p.m. so that we have time to get everything in place, meet each other, and review the night's events. There will also be time for a brief interview period between the panel of judges and the contestants individually. We're hoping to start the stage contest at 11:00.**

**The interview period will be your opportunity to meet the judges, and the judges to meet you and get to know your ideas on an individual candidate basis. Judges will be free to ask any questions that they wish, in an effort to get to know more about you and your involvement in the leather lifestyle.**

**The basement will be open during the contest ONLY to contestants, an assistant if you wish one to help you change, judges, and bar personnel. Someone from the bar will be present whenever anyone is in the basement, and it will be locked when everyone is upstairs. We do ask that you keep whatever you bring with you in as small an area as possible, as the bar cannot be responsible for lost items.**

**Depending on the number of contestants, we may be able to progress leisurely or may need to run things pretty tight. Your cooperation is anticipated.**

**Since the winner of the title "Mr. Detroit Eagle" is eligible to compete at the International Mr. Leather Contest in Chicago on Memorial Day Weekend, 2010, we will follow a stage format similar to that used at IML. There will be three appearances on stage.**

**The first appearance is considered Bar/Cruise wear. Contestants are asked to wear whatever they think they look good in - something you'd wear when you'd want to look particularly hot. This will be your first introduction on stage.**

**The second appearance is in jockstrap. You can also wear a hat, boots, vest, armbands, harness - anything additional that you think looks good.**

**The third time is "full leather". At IML, contestants are expected to wear ONLY leather on stage. At our contest you are asked to present what you consider to be a "full leather" image.**

**At each of the three phases, you will be asked a question on stage. The MC will have a series of questions on folded pieces of paper - you'll be asked to pick one, the MC will read the question, and you'll have about a minute to answer. The questions cover a wide range, from the leather community to relationships to important issues facing the gay community. When done, the question goes back in the mix - so two contestants may get the same question.**

**Thanks for entering the contest -it should be an enjoyable night for all.**
